From the Director

Change is in the air, and this e-newsletter is just one of the changes you will see from GODR in the coming weeks and months. We've been listening to your comments and gathering input from registered neutrals and other sources throughout the state, and we're trying to respond to your needs. We're particularly excited about our **new insurance and retirement benefits program** for registered neutrals. See the article below.

Also, at the urging of the General Assembly, the Commission on Dispute Resolution has committed to making GODR a self-sustaining entity by FY2012. That means that as of July 1, 2011, we will no longer receive any support from state taxpayer funds. The Commission has developed a realistic plan to generate the revenue needed to operate this office while at the same time increasing opportunities and benefits for you.

A critical part of the Commission's plan has been GODR's integration into the Administrative Office of the Courts, where we now can share resources with other judicial regulatory agencies and receive much-needed technical and administrative support. In the long term, the AOC's support and the fiscal freedom from the legislature will allow us to focus more of our energies on improving the state ADR system for our constituents – our registered neutrals working in Georgia courts and in other areas, our local ADR court programs, our trainers, and the litigants, lawyers and judges who use our system.

This e-newsletter will now come to your mailbox monthly. Each month we will include news from GODR, link to upcoming training and CE opportunities, and articles of interest to all of us who mediate or arbitrate for a living. If you have ideas for articles, please forward them to us.
