 - 1. **Appendix B: Training and Qualifications of Neutrals** Ms. Melissa Heard, Chair of the Committee on Training and Credentials, provided a synopsis of updates made to Appendix B of the Supreme Court ADR Rules, as presented by the Committee.

Ms. Peggy Wilson made a motion to adopt all changes as written. Mr. Randy Weiland seconded the motion. All remaining members voted in favor, with Ms. Sandy Bair and Ms. Edith Primm voting by proxy.

2. **Training Program Guidelines:** Ms. Heard provided a synopsis of updates made to the Training Program Guidelines, formerly known as the Training Approval Guidelines, as presented by the Committee on Training and Credentials. Clarification was provided as to the number of hours expected for role play in a Domestic Relations Mediation training.

Mr. Weiland made a motion to adopt all changes as written. Judge Cuthpert seconded the motion. All remaining members voted in favor, with Ms. Bair and Ms. Primm voting by proxy.

3. Appendix A: Uniform Rules for Dispute Resolution Programs – Ms. Tracy Johnson presented the edited version of Appendix A of the Supreme Court Rules and provided an outline of changes. There was discussion as to the issue of capacity and exceptions to confidentiality. Judge Charles Auslander suggested an edit be made and the specific language to read, "as provided by the Supreme Court of Georgia in Wilson v. Wilson [case citation]."

Judge Auslander made motion to update the language in Appendix A, which references capacity and exceptions to confidentiality, as outlined above. Judge Cuthpert seconded his motion. All remaining members voted in favor, with Ms. Bair and Ms. Primm voting by proxy.

Ms. Wilson then made motion to adopt all changes to Appendix A of the Supreme Court ADR Rules, including the friendly amendment on capacity and confidentiality. Judge Auslander seconded her motion. All remaining members voted in favor, with Ms. Bair and Ms. Primm voting by proxy.

4. **Model Court Mediation Rules** – Ms. Johnson presented the edited version of the Model Court Mediation Rules. As the Model Court Mediation Rules should work in tandem with Appendix A of the Supreme Court ADR Rules, suggestion was made to update its language with regards to the matter of capacity and confidentiality.

Judge Auslander made motion to update the language in the Model Court Mediation Rules, which references capacity and confidentiality, as it is outlined in the adopted version Appendix A. Judge Cuthpert seconded his motion. All remaining members voted in favor, with Ms. Bair, Judge Barwick, and Ms. Primm voting by proxy.

Judge Renata Turner then made motion to adopt all changes to the Model Court Mediation Rules, including the friendly amendment on capacity and confidentiality. Ms. Wilson seconded her motion. All remaining members voted in favor, with Ms. Bair, Judge Barwick, and Ms. Primm voting by proxy.
